

The Supreme Court of Missouri, in an order dated September 30, 2008, repealed subdivisions (a) and (c) of subdivision 5.245, entitled “Suspension for Failure to Pay Tax,” of Rule 5, entitled “Complaints and Proceedings Thereon,” and adopted a new subdivision (a) and a new subdivision (c) of subdivision 5.245, “Suspension for Failure to Pay Tax.”

This order was effective September 30, 2008.
